- 10' x 10' spaces are available for \$40.00 per space. All booths will be set up on the grounds of Meador Park.
- Vendors must provide tent, tables, chairs &/or other equipment required to sell their products.
- Electricity is NOT available.
- Set-up hours are between 8:00 & 10:00 am Saturday, November 6, 2010.
- Vendors must set-up in the area designated. Must be set up & open by 10 am, & remain until 6 pm.
- Vendors must leave their area in the condition it was found. Common area garbage cans are available, but we encourage vendors to bring a small trash receptacle for their booth area.
- Handmade and manufactured goods are welcome; however the Vendor Committee reserves the right to refuse any application.
- Items the Festival Coordinators deem inappropriate or illegal will not be allowed to be sold on the premises.
- Vendors will receive an informational packet with required passes for parking upon receipt of vendor application and booth fee.

**APPLICATION MUST BE COMPLETED AND RETURNED BY OCTOBER 25th.**  
**VENDOR SPOTS WILL ONLY BE RESERVED WITH RETURN OF APPLICATION AND PAYMENT**

- ❖ All returned applications must be accompanied by a check or money order for the full amount owing, made payable to **Seabrook Festival 2010**.
- ❖ The fee is **\$40.00** for a 10x10 space for the one-day event. If you need more than one space (a 10 x 20 space) the fee is \$80.00. This fee is non-refundable once notice of acceptance has been mailed.
- ❖ All applicants must send a completed application and Hold Harmless Agreement (below) signed and dated. Notification of acceptance will be mailed within a week of receiving your application.
- ❖ You will be informed of your space when you arrive on November 6<sup>th</sup>. Assignment of booth space and location is at the discretion of the Festival Committee.
- ❖ Seabrook Festival 2010 reserves the right to refuse participation to any applicants with displays or items deemed unprofessional in any manner.
